RESOLUTION OF THE TOWN OF PHILLIPSBURG, COUNTY OF WARREN, STATE OF NEW JERSEY APPROVING ONE-YEAR EXTENSION TO THE INACTIVE PERIOD, EFFECTIVE AUGUST 31, 2024.

LICENSE NUMBER 2119-33-011-006 FROM CLAUDIO'S ITALIAN CAFÉ LLC TO MICHAEL PICHETTO

WHEREAS, the Town Council of the Town of Phillipsburg, County of Warren, State of New Jersey hereby approved the transfer of the aforesaid CLAUDIO'S ITALIAN CAFÉ INC. to MICHAEL PICHETTO, R2024-68, simultaneously with this one-year approval, at a minimum, wherein said license may remain inactive for one-year terms filed for an additional four years, effective August 31, 2024, and

WHEREAS, the State of New Jersey having passed (S-4265/A-5912) wherein the Division of Alcoholic Beverage Control has issued Administrative Order (AO-2024-03) which shall divide all inactive licenses into quartiles based on the length of inactivity, and

WHEREAS, the quartile of inactive licenses that have been inactive for the longest period of time are required to be activated or transferred within one year, and

WHEREAS, the quartile of inactive licenses that have been inactive for the second longest period of time is required to be activated or transferred within two years, and

WHEREAS the quartile of inactive licenses that have been inactive for the third longest period of time are required to be activated or transferred within three years, and

WHEREAS the quartile of inactive licenses that have been inactive for the shortest period of time are required to be activated or transferred within four years, and


NOW THEREFORE, BE IT RESOLVED the Town Council of the Town of Phillipsburg, County of Warren, State of New Jersey can hereby approve a one-year approval of inactivity, on an annual yearly basis within a four-year period said license may remain inactive for an additional four years, effective August 31, 2024,

BE IT FURTHER RESOLVED the Town Council of the Town of Phillipsburg, County of Warren, State of New Jersey has approved a (1) one year extension of inactivity, effective August 31, 2024 to June 30, 2025. If the license is to remain inactive after June 30, 2025, another (1) year extension request will need to be filed asking for the Town's approval, and

BE IT FURTHER RESOLVED that approval of the extension is subject to completion of all State of New Jersey, Division of Alcoholic Beverage Control regulations as well as closing on the purchase of the liquor license and Michael Pichetto and Claudio's Italian Café, Inc.
